Sir,

The employees of AIR & Doordarshan are grateful to your good self for accepting our request for retention of employees and assets with the Government of India and thereby to protect the National Broadcaster as well as the Public Service Broadcaster of the country. The assurance from your kind self on 27/09/2007 that "*your good self fully agree with the decision of the meeting held with Secretary, I&B and assure employees to defend their cause not only before GoM, if necessary before PM too*" has reaffirmed your concern towards the employees and thereby created a ray of hope amongst the employees.

In the meeting on 27/09/2007 it was agreed that the Ministry will put forward the proposal that employees of AIR & DD will continue to be Government employees and one committee chaired by Secretary I&B was constituted to recommend the amendments in PB Act. Though the committee, in its second meeting held on 18/3/2008 agreed to propose our demand to the Hon'ble GoM, it is learnt that the meeting of the Hon'ble GoM held on 03/04/2008 have not discussed the most vital issue of retention of employees & assets with the Govt. On the other hand, it is also learnt that the issue of financial & capital restructure of Prasar Bharati was discussed in detail in the meeting of the Hon'ble GoM. It is a fact that if the Hon'ble GoM can take a final decision in favour of retention of employees and assets with the Government as it is the responsibility of the Government of the day to protect the National Broadcaster as well as Public Service Broadcaster.

The Federation strongly feels that the deliberations in the meetings on capital restructuring in isolation, without taking final decision on assets, is not in line with the agreement.

It was also decided in the meeting on 27/9/2007 that all the facilities of central Government employees would be restored immediately. But

unfortunately the orders in this regard have not been issued even after more than six months of the assurance.

Sir, under these circumstances, the employees of AIR & Doordarshan throughout the country are forced to launch the 4<sup>th</sup> phase of agitation as mentioned below:

1. 01.05.2008: Sending telegram from all stations to Chairman, Group of Ministers & Minister for Information and Broadcasting.
2. 06. 05.2008: Lunch Hour Gate Meeting at Akashwani Bhavan at Delhi & all other stations of AIR&DD.
3. 19.05.2008:  
to : Work to Rule  
23.05.2008: Lunch Hour Gate Meeting on 19 & 23.05.2008
4. 03.06.2008: Pen down/ Tool down strike ( from first shift to last shift )
5. 24.06.2008:  
to Pen down/ Tool down strike for 72 hrs. (from 1st shift of 24/6 to last shift  
26.06.2008: of 26/6/08). Lunch hour Gate meeting at all stations on these three days


It may also be kindly noted that NFADE will be compelled to go for immediate agitation without notice under the following circumstances:


In case of pay revision of any cadre in isolation without considering all the categories of AIR & DD, including the employees represented by the constituent Associations of NFADE.


