Subject: Seeking information under RTI Act, 2005.

Sir,

In view of communication vide File No.515/21/2011-BA(E) dated 19/10/2015 under signature of Sh. Sanjay Dhar, US(BAE), MIB, New Delhi. Kindly provide the following information:

1. Kindly provide the list of 434 members of ARTEE who are going to be benefitted from the order in O.A.No.4012/2014 along with their date of joining.
2. Has DG: AIR confirmed that all 434 members belong to ARTEE through the DDOs of their respective kendras.
3. If the number of beneficiaries come out to be less or more than 434, what action may be taken against the officers and office-bearers involved in the implementation of order.
4. Is the aforesaid order dated 19/10/2015 going to be implemented on ADTEA's members. If not, the reason thereof may be provided.
5. Had Delhi High Court in WP(C), Nos. 2071, 2094, 2095, 3410 directed that principle of "One Cadre One Pay" will be applicable to the members of one particular association.
6. Do the EAs (having joined before 05/10/2007), who are members of ADTEA, not the employees of Government of India?
7. What efforts have been done by the office of DG: AIR to implement 'One Cadre One Pay' on all EAs including those who are the members of ADTEA.
8. Kindly supply the copies of proposals sent by DG: AIR to MIB on the issue.
9. Please supply the copy of ARTEE's representation regarding 434 members and list of members provided.
10. Who is responsible for leaving out ADTEA members from the ambit of benefit accruing due to 'One Cadre One Pay' order passed by High Court in WPs(C) mentioned in item no. 5 above.



11. Is it not a fact that CAT (PB) of Delhi has in principle directed to implement the orders of Delhi High Court/ Hon'ble Apex Court on the issue of 'One Cadre One Pay' under which all EAs are covered.
12. What action has been taken on ADTEA's letter no. TEA/2014/MIB(M)/07 dated 13/06/14 to Hon'ble Minister of I&B, CEO,(PB), DG:AIR & DG:DDN on the subject of 'One Cadre One Pay'(copy enclosed)
13. It is not fact that if the relief finalized at the doorstep of Delhi High Court & Hon'ble Supreme Court is not extended to EAs of ADTEA, they will also have to approach the court once again resulting in encouraging litigation.
