Meanwhile we are ready to re - consider the agitational programme in case the Charge sheets issued to 4 employees are withdrawn immediately to ensure natural justice and for the wider interest of the smooth functioning of the National Broadcaster.

It is pertinent to note that if the demands are not met on or before 18.11.2016 we will be compelled to intensify our agitational programme for which O/o DG:AIR shall be responsible.
