Subject: - Request for grant of a meeting and to set up a high level inquiry committee immediately to stop victimization of selected few employees and office bearers by DG-AIR

Hon'ble Sir,

With due respect, it is to inform you that a protest was held on 08-09-2016 at Akashvani Bhawan and the reasons for same are mentioned below:-

- On dated 07-09-2016 the entry of all employees below the ADGs stopped from newly constructed automatic glass door by an written order.
- The specially deployed security guard along-with one gunman stopped all the officers upto the rank of Deputy Director General that this gate was for the exclusive use of DG and ADGs being as VIP.
- This unexpected sudden restrictions imposed shocked all the employees working in the said building.
- The staff was angry as the entry from this gate provides an immediate approach to Lifts, and stairs Bio-metric attendance machines.
- The huge number of staffers are staff is working in this building and everyone wants to mark his attendance immediately without wasting even few seconds.
- The staff along-with few major Associations on considering the sentiments of their members reacted sharply and assembled at the gate of Akashvani Bhawan on dated 8-9-2016 during lunch hour.
- All major associations' Presidents and General Secretaries addressed the gathering and it was decided to meet the DG on the matter.
- Initially DG was reluctant to meet the staff representatives but around 4 pm realizing his mistake ADG announced that DG had agreed to keep the order dated 7-9-2016 in abeyance and that the gate shall remain open for all in
