Sub :- Request for implementation of CAT(PB) orders of O.A. No. 4339/2015 and 4254/2015 disposed of on 10/12/15 and 21/03/16 respectively for considering the grant of pay-scale of Rs. 6500-10500 to Engineering Assistants

Sir,

This is to bring to your kind notice that Engineering Assistants appointed in AIR & Doordarshan till 05/10/2007 have been approaching the CAT for grant of pay-scale of Rs. 6500-10500 to them.

Major chunk of such EAs have been granted the desired pay-scale in pursuance of various judgements passed by the CAT, New Delhi, in line with judgements dt. 31/05/2006 in case of Lalit Kumar Vs. Union of India (OA NO. 1742/2004) and Mahender Singh Rana & Ors. (OA NO. 1743/2004) as upheld by Hon'ble High Court of Delhi in W.P.(C) No. 2095/2007 & W.P. (C) No. 2094/2007 vide judgement dated 07/09/2010 and finally upheld by Hon'ble Apex Court on 14/01/2011.

Despite several judicial pronouncement, 47 EAs who were equally placed and at par with the applicants in the aforesaid OAs were compelled to obtain order dated 10/12/2015 in their favour in OA NO. 4339/2015. Later on, under compulsion, our association also filed an OA NO. 4254/2015 to claim the same relief for the EAs left out in our association and vide its order dated 21/03/2016 the Hon'ble CAT has directed the respondents to consider our detailed representation dated 13/06/2014 for the members of applicant association and another applicant Mr. Sanjay posted as EA at AIR-Rohtak.

It is requested that since the pay-scale of Rs. 6500-10500 has already been granted to most of the EAs working in AIR & Doordarshan, therefore, all the remaining EAs appointed till 05/10/2007 may kindly be accorded the same benefit in the interest of justice and fair-play.
