With due respect it is to inform you that the above draft notification created lots of doubt in the mind of Subordinate Engineering Employees. We have submitted our resentment on dated 3-6-2016 (enclosed) but instead of calling ADTEA, this draft notification is issued. Moreover the copy of same is not endorsed to our Association .

The present draft clearly shows that Engineering Asstt and Technicians in present scenario shall be entitled of one promotion in their entire service carrier if implemented.

The present draft is partial and is not included the plan of increasing promotional prospects for subordinate engineering employees.

If implemented the Technician will retire as Technicians and Engineering Assistant and Senior Engineering Assistant will be retired as Junior Engineer.

This draft does not include the promotional prospects of Helper, DED, Diesel Tech, Mast Tech, Assistant Engineers.

We strongly oppose these draft R/R's and if our suggestions are not included in the present draft we will be force to start the agitation with immediate effect. **Please treat this letter as notice of agitation.**

Please grant us an urgent meeting on the matter.
