Sir,

Kindly provide the following information/documents by duly certifying the same:

1. Provide the list of all the court cases filed by the employees of AIR&DD in which our department i.e., DG, Prasar Bharati or MIB is a party starting from the year 1990 throughout the India along with the gist of said such cases, their party names, case nos. and the judicial fora where pending or decided till date.
2. Also reveal the total expenditure incurred in contesting such court cases, names of the advocates and the fees paid to them on the case wise basis till date since 1990.
3. In how many cases, efforts were done by the authorities to reach out-of-court settlement with the aggrieved parties/employees and the success rate thereof.
4. Since 1990 till date, provide the list of cases that have been won by the department and their type (whether original case, appeal, review, revision or SLP etc.) and also list of those cases lost by the department, gist of their nature and names of the judicial fora.
5. Provide the copies of all administrative orders (if any) passed by the authorities (AIR/DD, Prasar Bharati or MIB) as a result of which some court cases became in fructuous or withdrawn by the aggrieved parties clearly indicating such necessary details of the court cases required for their identification i.e. type of cases, party-names and judicial fora where pending before disposal thereof.
6. Provide the details of total expenditure incurred including advocate free in contesting the case of pay-parity of Technicians vs. Lighting Assistants from the stage of Madras CAT, Madras High Court and Honorable Supreme court filed by ADTEA (Judicial Forum wise).
7. Provide the details of total expenditure involved including Advocate-fee in contesting the case of pay-parity of Technician VS. Lighting Assistant from the stage of CAT Delhi up till Supreme Court filed by ARTEE (Judicial Forum wise).

8. Copy of the Order/Rule under which Lighting Assistants were given pre revised scale of Rs. 5000-8000 w.e.f 01-01-1996 or due to court's intervention.
9. Total number of court-cases(service matters) being contested at present by MIB/DG:AIR/DG:DD/ Prasar Bharati throughout the country. Pl inform cadre-wise and where pending.
10. Provide the copies of all affidavits/counter-affidavits filed by the authorities in OA No. 164/1996.
11. Name the competent authority empowered to grant recognition to the service associations of AIR and Doordarshan.
12. Is DG:AIR or DG: Doordarshan empowered to put undue restrictions on the working and freedom of the recognized associations. If yes, kindly enclose the copy of rules/regulations.
13. How many Departmental council meetings have been held in the MIB for the last 15 years on the pattern of JCM. Kindly, supply the copies of their minutes.
14. After how long Departmental Council Meetings are required to be held as per Rules? Please also quote the relevant rules/instructions in this behalf.
