Subject:- Complaint against Ms. Ruchi Agarwal, Director(EPC) for adopting delay-tactics in all sorts of administrative work.

Sir,

This is to bring to your kind notice that the above mentioned Director (EPC) is causing unnecessary delays in the following administrative works:-

1. Delay in clearing MACP cases of Helpers/ Diesel Engine drivers/ Diesel Technicians due to which the employees are become restive and demoralized. Unlike other zones where all such cases have been settled.
2. Delay in release of seniority list of Technicians and Senior Technicians every year.
3. Delay in updating the data of Engineering staff on AIR roll as is being done in the case of staff posted on DD roll.
4. Intentionally not taking any action on the cases of compassionate grounds with respect to Technicians and Helpers.
5. Delays in the allotment of staff quarters of Kingsway to the eligible employees.
6. Delay in taking action on the case of notional pay-fixation of EAs promoted due to CAT's order in 1999(about 23 cases) despite letter from the Vice President of the association about one and a half years back.

Despite above said problems, Director (EPC) is always having negative attitude in dealing with the cases represented by our registered and recognized association. She lacks devotion to duty and is also not paying due respect and attention to the elected office-bearers of the association and Sh.
