I want to put up progress on different matters before all of you.

(1) HELPERS ACP CASE

Friends as you know that Govt.has approached Delhi High Court challenging Principal Bench CAT, New Delhi judgment in Rishi Raj and others case(In this case ,after implementing to its petitioners of DDK Delhi.

ADTEA is protesting the case in court. As the matter is in court, so other options may be sought to settle the issue. ADTEA is pursuing implementation of Cadre Review as proposed by Shri R.K.Singh Committee and also directed by Principal bench CAT,New Delhi in Rishi Raj and others case(Shri R D Mishra and other ADTEA members are also petioners in this case).Helpers to be renamed "Broadcast Assistant "with enhanced qualification I.T.I. Certificate (incumbents will be treated at par on qualification).

(2) Technician, Sr.Technician, Diesel Technician, Mast Technician and Diesel Engine Driver-

Friends my heartiest congratulations for implementation of Tech/LA Parity order. ADTEA spent more than Rs 12.00 Lakhs at various levels to settle the issue through the court. Our senior leader Shri Kulbhushan Bhatia played key roll .Mr Bhatia was the main personality in this case. If sister association waited till implementation of the Kulbhushan Bhatia case with arrear, we definitely got arrear. Still one of our case is pending in Chennai High Court for arrear benefit and revision of Sr. Technician scale. The case has already won by ADTEA in Chennai High Court.

ADTEA will now speed up our efforts for merger of these cadre in to one in the name of "Junior Broadcast Engineer" with enhanced qualification Diploma in Engineering (incumbents will be treated at par on qualification) by Cadre Restructuring. The same had been approved by Shri R.K.Singh committee Report. The scales of Tech and Sr. Tech are merged on 01/01/1996 as 5000-8000 therefore merger from 01/01/1996 will be demanded by ADTEA.

Congratulations to all 5K E A friends for implementation 6.5 K scales. (5) E.A./S.E.A./A.E. Case of ACP and Corrigendum of Up gradation word in 25/2/1999 order with reference to 05/12/1997 and 2001 order of Sound Recordist-

(A) ADTEA has already written letter for replacement of E A scale from 01/01/1996 in the scale of 6500-10500 as had been issued to Sound Recordist by DG Doordarshan in 2001, whose pay parity was extended to E A after judgment of Hon'ble Apex Court, removing the curse of order dated 25/02/1999. Recently Shri Anil Kumar Gupta Vice President, Shri Umakant Joshi Joint Secretary and Shri Akhilesh Srivastava had a meeting on 17/5/2017 with Joint Secretary MIB in her chamber in Shastri Bhawan, New Delhi. Shri Ajay Joshi Dy. Secretary MIB was also present. Both the officers were kind enough to give patience listening for issue of replacement scale of E A and assured positive outcome.

(B) A C P PATNA -

ADTEA has already started the process to go to court of law by challenging speaking order of DG: AIR of October 2015.

(C) Criminal Conspiracy case against DG AIR-

Mr. U.K.Joshi EA AIR BH New Delhi and Joint Secretary ADTEA Central body and Mr. Vinod Kumar SEA NABM Delhi and Joint Secretary (NZ) has already filled the case in the High Court Delhi in individual capacity for starting criminal conspiracy against D G AIR Speaking order of October 2015 by OA No.2591. Already 5 hearing has gone but Govt. failed to file reply before court. The next hearing will be in the month of July 2017. ADTEA is stood with him in all respect, if they wins, this will be game changer fo EA/SEA/AE Cadre.

(7) Organizational Matter-


