Subject:- Rotational transfers of officials posted at sensitive posts.

Sir,

This protest letter of our association highlights the extent and manner to which a well intentioned direction/instruction of CVC can be manipulated to the detriment of the employees.

The genesis of the problem lies in the twisting and distorting of the facts contained in a circular of CVC so as to give it a different color by generalizing the specific instructions. The crux of the matter is that the Secretary of CVC issued a circular No. 03/09/13 dated 11-09-2013 wherein all departments of Government of India were advised to follow the instructions regarding the rotational transfers of officials posted on sensitive posts to thwart the evil of developing vested interests. Consequently, when the aforesaid instructions reached the office of DG:AIR, the stalwarts of its administrative wing did not leave any stone unturned to misinterpret the true spirit of the instructions and issued a Memorandum bearing No. A-11019/05/2014- Scor dated 09-04-2014 under signature of Dr. Sanjay Dubey, ADG(A) wherein the instructions contained in the said circular were generalized by directing all Zonal ADGs(E), ADGs(P) and Head of the Capital Stations to transfer all such officers/Officials who had completed more than 15 years at one station excepting Group 'D' officials and the compliance thereof was also sought latest by 31-05-2014.

In the impugned O.M, this fact was completely forgotten and ignored that the instructions contained in the CVC's circular were meant only for the sensitive posts so that the longer stay of the officials on their respective posts may not degenerate into any corrupting influence.

The aforesaid memo triggered a spate of letters from different transferring authorities to the Head of the Offices seeking information regarding the staff

members staying at one zone and station for more than 15 years. Resultantly, the aforesaid instructions have sent shock waves through employees of all the cadres of AIR & Doordarshan due to fear-psychosis related to transfers. The said O.M has provided long handle to the officers to unnecessarily target the subordinate cadres due to one or the other reason in the name of complying with the same. Due to this the employees are feeling demoralized and have become restive.

The employees in general believe that O.M in question has been released intentionally or else under some misconception-- either way, it is repressive and entails serious consequences.

Therefore, in view of the above narrated facts and circumstances, it is requested that in order to allay the fear of panic/stricken employees, necessary action in this regard may kindly be taken for changing the meaning and purport of a well-intentioned letter communicating instructions and the said Memorandum may also kindly be ordered to be withdrawn.
