
OFFICE ORDER

In accordance with the instructions contained in the DOP&T O.M. No. 35034/3/2008-Esst.(D) dated 19.05.2009 regarding grant of Modified Assured Career Progression Scheme (MACPS) for the Central Government Civilian employees, approval of the competent authority is hereby accorded to grant the MACP to Group D officials working in all AIR Stations. The financial upgradation shall be from the Pay Band-I (5200-20200) with Grade Pay of 1800/- to the PB-1 (Rs. 5200-20200) with Grade Pay of Rs 1900/-.

2 The Respective Heads of Stations/Station Directors are the appointing Authority in respect of Group D employees hence all the Station Heads/Directors have to constitute the Screening Committees in accordance with the MACP Scheme and release the list of eligible employees. The MACP Scheme be implemented within one month for all employees. A compliance report to this effect may be furnished to this Directorate

3 No stepping up of pay in the pay band or grade pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under MACP Scheme

The financial upgradation shall be from the Pay Band -1 (Rs. 5200-20200) with Grade Pay of Rs. 1800/- to the PB-1 (Rs. 5200-20200) with Grade Pay of Rs. 1900/-

2. The respective Heads of Doordarshan Kendras are the appointing Authority in respect of Group 'D' employees, hence all the Doordarshan Kendras have to constitute the Screening Committees in accordance with the MACP Scheme and release the list of eligible employees. The MACP Scheme be implemented within one month for all employees.
3. No stepping up of pay in the pay band or grade pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under MACP Scheme.
4. The MACP Scheme would be operational w.e.f. 01-09-2008. In other words, financial upgradations as per the provisions of the earlier ACP Scheme (of August, 1999) would be granted till 31.08.2008.
5. The up gradation will be further subject to the terms & conditions stipulated in the DOP&T O.M. dated 19.05.2009 referred to above.
